## **«Achieving International Corporate Tax Certainty in an Uncertain Tax Environment»**

**Venue: Mohammed Bin Rashid Library – Auditorium, Dubai**

The International Tax Law and Policy Research Network (ITLRN) will host its fifth international tax event in Dubai (UAE) to discuss **the current sources of International Corporate Tax Uncertainty for MNEs** and the mechanisms available to States to grant tax certainty in order to **retain / attract foreign investments into their territories**.

This event follows the successful completion of our networks past four events which were held in Belgrade (2022 with 150 participants), Milan (2023 with 200 participants), Vaduz (2024 with 220 participants) and London (2025 with 300 participants).

The speakers in this event include renowned experts with different backgrounds coming from academia (prominent tax law professors), tax administration/competent authorities, policy making organisations (for example OECD, ATAF and UN), members of private practice (international corporate tax and transfer pricing partners) and tax directors from different MNEs.


